The ARFFWG Board of Directors consists of fifteen (15) Directors who carry out the management functions of the ARFFWG. Of the fifteen (15) Directors, five (5) Executive Board Officers are chosen who are delegated to run the day-to-day administration. Each odd year, odd number section Director positions are open and must be filled. Each even year, even number section Director positions are open and must be filled. All Board of Director positions serve a two (2) year term and may be elected to three (3) consecutive terms, totaling six (6) years. Becoming a director is an excellent opportunity to be directly involved in the management of ARFFWG.

Nomination forms must be postmarked by June 16, 2023 or e-mailed no later than June 26, 2023. Please use the attached nomination form. All nominations received by the deadline will be given an opportunity to speak in front of the members at the Annual Symposium. Nominations will not be accepted from the floor.
